I hope you were able to attend the Women's March in Arcata on March 24th that was led by students to urge our legislators to repair our laws that now allow easy access to semi-automatic weapons and bump stocks for rifles. Anne Hartline organized the Sunday March 18 member program to seek consensus on a proposal to make the elimination of the Electoral College an action focus for 2018-2020. This issue will likely be on the agenda for the 2018 national convention in late June. The members attending our meeting were unanimous in support of recommending that our representatives to the convention should support this action focus. The Board will make a final decision on this issue at our April 3rd Board meeting. Come to the meeting if you would like to add your perspective to this item.

Our local League needs a Voter Service Director. The responsibilities of this job are: Oversee and coordinate the League's efforts to provide nonpartisan information to voters and to promote citizen participation in elections. Mary Lou Lowry has organized League efforts to support a ballot initiative to make a change to state Proposition 13 that could bring as much as \$11 billion dollars to state coffers to support schools and local governments. **Mary Lou** and I were able to get more than 90 voters to sign the petition when we tabled at a local merchant. Chris Carson, the President of the national League, just informed us of the following good news: "Yesterday, in a victory for Pennsylvania voters, the U.S. Supreme Court declined to block the recently redrawn Pennsylvania congressional districts from moving forward."

Members of the LWV met with County Supervisor Mike Wilson of the Third District on the morning of March 7. LWV members present were Rollin Richmond, Julie Kelly, Byrd Lochtie, Leslie Leach and Elaine Weinreb.

The initial purpose of the meeting was to discuss how to get support for climate change funding into the proposed state and federal platforms for 2018. However, conversation during the meeting broadened to include other issues that Supervisor Wilson is concerned about.

A. Climate Change. State planning law dictates that local communities address climate change issues in their general plans. Wilson feels that the most important things that the Board of Supervisors could do to mitigate climate change is to pass a resolution emphasizing this dire threat, and asking the Trump administration to reverse its decision to abandon the Paris Climate Accord.

Wilson suggested working with Tom Wheeler of EPIC and Colin Fisk, an Arcata activist who is involved with climate issues, and then to work with Planning Director John Ford to help the planning staff find information on these issues. Wilson would also like to see research on what other counties have done along these lines. When we have this information together, the LWV should draft a letter and have Wilson look at it before sending it to the Board of Supervisors. He would like all this to happen before the June elections.

B. The Bareilles Subdivision Issues. This involves the questionable legality of subdividing parcels primarily for the benefit of marijuana growers. This item was briefly discussed at a previous LWV board meeting. Wilson would like an LWV letter about this issue, too.

C. Gun Control. Several Humboldt retailers sell assault weapons. There are state legislative issues on gun control that Wilson would like the Board of Supervisors to support. The LWV

D. Proposition 13. What does the California State Association of Counties (CSAC) say about this issue? What does the Rural County Representatives of California (RCRC) say about it? Who are the chief advocates pro and con? What resolutions have other counties made on this issue? How would changes to Proposition 13 affect the county budget? How would it be divided up?

Would it go directly back to the county? The LWV should contact local school boards, especially in the fourth and fifth districts, and see who they feel about it.

E. The Mercer-Fraser water pollution issue:

We need to review the Planning Commission's decision on this issue, and find out if their vote followed their own guidelines, concerning how many members must vote and who was absent or recused. Why is the Board of Supervisors refusing to hear the appeal made by the Humboldt Bay Municipal Water District? What changes need to be made to the General Plan to keep such an issue from happening again?

There is certainly plenty here for the LWV to do, and we need to decide if, how, and by whom this work will be done. Let us discuss this at a board meeting soon.

2018 Humboldt County History Day

LWVHC has been pleased to participate in the county history day for the past several years. Each February, students in 4th grade through high school compete in Humboldt County History Day, held at Humboldt State University. Through the rigorous process of researching and preparing creative and original History Day projects, students learn and analyze issues, ideas, people and events in history. This year's theme was Conflict and Compromise. Projects can include posters, exhibits, websites, papers, and performances. This year's participation was the largest ever with 600 projects from 440 students representing 31 schools, 75 teachers and over 100 judges and event helpers!

Students choose from several categories to explore the theme and may work independently or in a group. We reviewed over 300 projects in the categories of Posters and Exhibits and awarded eight book gift certificates to students whose projects were in line with the League of Women Voters mission or history. A tough decision with so many great projects. The projects we chose to award ranged from Hidden Figures at NASA to Women in the military.

All of the students we chose were continued on to the next stage of the competition! We are looking forward to the next phase of these and other local projects are selected to advance to State History Day in May.
